Good afternoon Suffield Public Schools Community,

Although not unexpected, COVID-19 cases continue to trend upward throughout communities across the state and country. I remain very hopeful that this resurgence will be short-lived and the transmission less impactful due to the mitigating strategies our health officials have identified and recommended that we all follow. With the recent spike in positive cases across the region and our health metrics reaching levels not seen since last spring, it is important that we raise awareness about our current circumstances and the district's response to this evolving situation.

In regards to our district's operational status, <u>the Suffield Public Schools will remain in our</u> <u>hybrid status until further notice</u>. I share this important information with you as our current health metrics suggest less in-person learning if our trends continue over time. Please note *Addendum 4 - Updated Guidance for Decision-Making Regarding the Use of In-Person, Hybrid (Blended), or Remote Learning Models in Connecticut Schools during COVID-19 (click* <u>here</u>). This past Wednesday, district administration reviewed our operational status in response to increasing positivity rates with our health officials. Our ability to socially distance due to population density within our schools and classrooms, staffing levels, and the safety measures we continue to implement, we do not believe that a shift to full remote status is necessary at this time. However, it is important we remain mindful that this is an evolving situation and could impact our operational status at any time.

As we have done since March, the Suffield Public Schools will continue to prioritize engaging with our families during this health crisis. There is tremendous value in having an open line of communication with our community, as it serves to inform the decisions we are making on a regular basis. In keeping with our commitment to communicate, we will resume our hosting of periodic Parent Zoom Conference Calls beginning next Friday. Next week's Parent Conference Calls will be kept to one hour, hosted at 10:00 am and 2:00 pm, and provide an opportunity for parents to ask questions. Unlike last spring, parents of elementary and secondary students can attend either conference call. We may need to change this for future meetings, but next Friday's message at both meetings will be germane to elementary and secondary levels.
