

# **INVITATION TO BIDDERS**

# Town of Suffield, Connecticut June 18, 2020 Renovations to Pre-k Classrooms A. Ward Spaulding School 945 Mountain Road, West Suffield 06093

You are invited to submit a proposal for providing materials and construction services for the renovation of the pre-kindergarten classrooms at A. Ward Spaulding School. The project includes renovation of four classrooms including removing the current bathrooms in each room, installing a new bathroom in a slightly different location, installing a classroom sink, walls for a storage room, and cabinetry (bid as alternate).

The sealed bids will be received at the office of the Business Manager, Suffield Public Schools, 350 Mountain Rd., Suffield, CT 06078 until **10:00 AM on July 1, 2020**, at which time they will be publicly opened and read aloud. Bids transmitted by facsimile will not be accepted. All bids must be in a <u>sealed</u> envelope. Each envelope is to be marked on the front with the name of the project (AWS Pre-k Renovation) and the bidder.

Drawings and specifications are attached to this bid.

A mandatory Pre-Bid meeting, will be held at A. Ward Spaulding School at 10:00 AM on Wednesday June 24, 2020. (Note: Face masks will be required for this meeting. All attendees should follow appropriate social distancing guidelines.) Any questions should be directed to Bill Hoff, School Business Manager, at 860-668-3202 or bhoff@suffield.org.

No Bid will be accepted after the time set for the openings of bids and no bidder may withdraw his bid within 120 days of opening thereof. The Town of Suffield reserves the right to waive any informality or to reject any or all bids when such action is deemed in the best interest of the Town.

Non-discrimination in Employment: Bidders on this auction will be required to comply with the President's Executive Order No. 112246.

#### **Information for Bidders**

- 1. TAX EXEMPTION Purchase of materials for this project are exempt from Connecticut sales tax.
- 2. BID BOND- A 5% bid bond is required for this project. Any bid may be withdrawn by the bidder prior to the time scheduled for receipt of bids. No bid may be withdrawn within 120 days of the bid opening.
- PRE-BID MEETING There will be a mandatory pre-bid meeting on Wednesday, June 24, 2020 at 10:00 AM at A. Ward Spaulding School, 945 Mountain Road, West Suffield, CT 06093. The meeting will be held with Bill Hoff, Business Manager. Any questions should be directed to Bill Hoff at 860-668-3202 or by email at <u>bhoff@suffield.org</u>.
- 4. QUALIFICATION OF BIDDERS- The town may make such investigations as it deems necessary to determine the ability of the bidder to perform the work and the bidder shall provide the Town with any information requested for this purpose. The Town reserves the right to reject any bid if the investigation of such bidder indicates that the bidder is not qualified to complete the project or has previously failed to properly perform or complete on time any contract.
- 5. RIGHT TO REJECT BID-Any bid which contains any omissions, alterations of form, additions or alternates not called for, erasures or corrections, or any irregularities may be disregarded or rejected as improper except that the Town may waive any defects or irregularities. The Town of Suffield reserves the right to reject any and all bids in whole or in part or to waive any informality and non-material deficiencies in bidding if it is determined to be in the best interests of the Town of Suffield. Any bids that are submitted or received after the scheduled closing time for receipt of bids will be rejected.
- 6. ACCEPTANCE AND AWARD OF CONTRACT- Acceptance of bid will be by notice in writing signed by the First Selectman and mailed to the address designated in the bid form.
- 7. INSURANCE- The Town will not enter into Agreement with the Contractor for any work under this project until required insurance as detailed under SPECIAL CONDITIONS has been obtained and the Town has received certificates of insurance, nor shall the Contractor permit any subcontractors to commence work until similar insurance has been obtained and the Town has received certificates of insurance. All policies shall hold harmless the Town of Suffield and the Town and its agents shall be named additional insured. Each insurance certificate shall contain a statement by the insurance carrier not to cancel the policy except upon (30) days notice to the Town.
- 8. FAILURE TO EXECUTE CONTRACT- If the successful bidder fails to execute the contract within twenty (20) days after the mailing of the Notice of Award of the Contract, and then the Contractor shall be deemed to have refused to enter into the contract and to have waived all claims to the work. The Town shall then have the right to contract with the next acceptable bidder to perform the work under this contract.

# 9. WAGE RATES- **This project does require Prevailing Wage Rates**. The prevailing wage rates are attached.

#### 10. DEDUCTIONS – The following two Deductions are included in this bid

### Alternate No. 1: Cabinetry

Base scope includes removal of existing cubbies in all classrooms. As Add Alternate, provide custom millwork: wall-mounted cubbies and storage cabinets in all classrooms. Refer to 19/A1.21 for typical section.

#### Alternate No. 2: Floor Replacement

Base scope includes vinyl composition tile, VCT-1, in storage rooms and classrooms, to the extent indicated. As Add Alternate, provide rubber flooring, RB-1, throughout entirety of all classrooms and storage rooms. Remove existing flooring in classrooms and storage rooms in entirety and prep floors to receive new flooring. Refer to finish schedule.

#### 13. WORKSCOPE-

- A. The Project consists of the demolition of exiting bathrooms and installation of new bathrooms in a different location in the pre-k classrooms at AW Spaulding School. It also includes installation of cabinets in the rooms.
- B. The Work includes, but is not limited to the following:
  - 1. Providing all materials as specified.
  - 2. Demolition of existing bathrooms.
  - 3. Floor work to install water supply and drains for new bathrooms and sink in room.
  - 4. Installation of new bathrooms and sink.
  - 5. Creating a storage room for the classrooms which will require creating a doorway between each pair of classrooms connecting the storage rooms.
  - 6. Installing cabinetry in rooms.

#### **SPECIAL CONDITIONS**

- 1. TIME FOR COMPLETION This project is to be completed by August 25, 2020. If you are unable to meet that deadline, please state so on the bid form and provide an estimated completion date.
- 2. PERMITS A building permit is required for this project. It will be the contractor's responsibility to obtain the permit and final payment will not be made until permit is closed. The Building Permit fee is based on the State Educational fee of \$0.26 per thousand.
- 3. COORDINATION AND SCHEDULING OF WORK The work must be coordinated with the Director of Facilities.
- 4. WORKER'S COMPENSATION The Contractor shall also carry Worker's Compensation Insurance as required by the State of Connecticut for all employees engaged in this project. Sub-Contractors hired by the Contractor shall comply with this requirement unless their employees are covered by the protection of the Contractor's Workers Compensation insurance and the certificate of insurance furnished by the Contractor so stipulates.
- 5. The Contractor, Consultant, or Vendor agrees that this contract or purchase order and the actions of the Contractor, Consultants, or Vendors are subject to the provisions of the Suffield Code of Ethics as contained in the Town Ordinances.
- 6. Should the Contractor, Consultant, or Vendor be found by the Suffield Ethics Commission to have violated the Code, the Town may terminate this contract and take such other action as the Town may have at law or in equity.
